# SEBN General Business Meeting- Hoboken-10/29/2011

The General Meeting of the Southeast Bus Nuts was called to order by President, Charlie Bukoski at 10:10 AM.

- The invocation was given by Gerald Ensley
- The Pledge of Allegiance was led by Howard Best
- Introduction of new members (Throneberry's & Blalock's) by President Bukoski.
- Bertha Showman moved to accept the minutes from the 4/30/2011 as posted on the website and motion was seconded by Jack Campbell.
- Secretary's report was presented by Judy Bukoski, Secretary. She stated that we added two new members since our last rally giving us a current membership of 122. From the monthly FMCA report, new FMCA members who qualify for membership into SEBN are contacted each month. They are sent a brochure, introductory letter, application and website and next rally information. Of those listed so far this year, only two have joined SEBN (Cook's & Bowen's).

- Treasurer's Report was presented by Marty Nixon, Treasurer. Current balance stands at \$4832.96, which does not include current rally expenses. Use of PayPal for dues renewal and future rally fees was encouraged due to its efficiency and provides receipts to both the payor and treasurer. Early registration for future rally was encouraged to provide rally hosts with attendance indicators.

Rally expenses were stated as being unpredictable as they are dependent on attendance and unforeseen events or exposure.

The fee for using credit cards and PayPay was discussed and determined to be well worth the expense given the manpower and time saved and the benefit of receipts to all parties. Mike Heron moved to accept the treasurer's report as presented, seconded by Howard Best. Motion accepted.

- Webmistress report:

Lynne Silver was unable to attend the rally due to business commitments so report was presented by President Bukoski. He announced that Lynn Silver has agreed to continue to write the newsletter to the end of the current administration however, if a volunteer agrees to take on this position, she would step down at that time.

- National Director's report:

Bertha Showman reported she was unable to attend the national meeting Madison this summer but provided the membership with an extensive report on that meeting. She reported that of 487 Members, 373 were present and that the following were elected:
